

2016 CLUB RULES

THE MILLWOOD COUNTRY CLUB IS A UNIQUE FACILITY. EACH MEMBER SHOULD TAKE PRIDE IN ITS APPEARANCE, RESPECT ITS RULES, AND ENCOURAGE OTHERS TO DO THE SAME.

The Board of Directors has approved the following rules to be in effect. They augment, not replace, information in the club Bylaws.

I. MEMBERSHIP

A. Sponsors shall attend the mixers with their candidates to meet members of the Board. Sponsor/candidate/Board mixers can take place in conjunction with regular Board meetings.

B. Each membership unit has the right to sponsor three new membership units per year. The sponsoring membership unit must have been a membership in good standing for at least one year.

C. To remain a member, a child from a Full Family Membership must obtain his or her own club membership upon reaching the age of 25 or at the time of marriage if before the age of 25. There is an initiation fee, but letters of recommendation and meeting with the Board at a mixer are not required. Upon divorce or separation of members in Categories 2 through 5 in Article II of the Bylaws, both members shall be offered the opportunity to convert their membership to Individual Membership or Family Membership, as appropriate. All dues and assessments would be owed, but no new initiation fee would be levied to either.

II. GENERAL RULES

A. Due to the nature of the club, the honor system will prevail.

B. Dogs brought to club property must be leashed at all times. Any droppings must be picked up and properly disposed of. No pets are allowed in the clubhouse with the exception of assistance dogs.

C. Appropriate attire for each activity is expected for all participants.

D. Members and guests must be signed in before beginning participation in golf, tennis, or swimming.

E. Nonmembers may take lessons on club property from the tennis or golf pro at his or her discretion. These nonmembers must pay prevailing guest and cart fees to the professional, who will forward these monies to the club.

F. The golf course, the tennis courts, and the pool area are reserved at all times for the general use of the membership and their guests and shall not be let out or leased except that the Board of Directors, if they so choose, may allow the Bank of Clarke County to sponsor an annual charity golf event and may allow the Millwood Ladies Golf Association to sponsor an annual charity golf event.

III. GUEST POLICY

A. Any member in good standing may request a club courtesy card for a long-term house guest or guests from the club secretary. The club courtesy card will extend club privileges to a guest for a period of not more than two (2) weeks. Such guests may not receive more than two (2) courtesy cards per year. Guests who hold a valid courtesy card do not have to be accompanied by a member if they are over the age of eighteen. However, if they are not accompanied by a member, they must obtain permission to play golf from the Course Supervisor and sign up as a guest of their sponsoring member when playing golf, playing tennis, or swimming.

B. No guest fees are charged for nannies, au pairs, exchange students, and the like, when they are caring for members' children at the pool in the absence of the children's parents. In this case, the caregiver must sign in with his or her name and the word "employee," along with the names of the children in his or her care.

C. A guest who does not hold a valid club courtesy card may use the club sports facilities no more than twice a month. A guest without a valid club courtesy card must be accompanied by a club member when he or she is playing golf, playing tennis, or swimming; and the host member must personally sign in the guest before he or she uses the club's facilities.

Participation by guests in club-sanctioned member-guest golf and tennis tournaments and instruction by club-sanctioned professionals is allowed without counting against the monthly limit.

IV. GUEST FEES

- A. Tennis guest fee- \$ 8.00 per day
- B. Pool guest fee- \$ 5.00 per day
- C. Golf guest fee - (Greens Fee)
 - 1. Weekdays - \$16.00
 - 2. Weekends and holidays - \$20.00
- D. Golf Cart Fees (applicable to both members and guests) -
 - 9 holes - \$10.00 18 holes - \$20.00

V. TENNIS

- A. Only SMOOTH-SOLED tennis shoes are permitted.
- B. Proper care must be taken when leaving the upper courts to brush and scrape shoes so as not to track the abrasive material onto the porch and into the clubhouse.
- C. Matches in scheduled tournaments take priority over other tennis players. If others are waiting for a court, play must be limited to one hour.
- D. Players using the upper courts shall drag the courts and sweep the lines after play.

VI. POOL

- A. The official season for the pool is typically from Memorial Day through Labor Day.
- B. Splashing, pushing, or running are not allowed in the pool area. All persons using the pool do so at their own risk, and the club assumes no responsibility for injury, damage, or loss of property. Children under fourteen (14) must be supervised by a qualified adult. The lifeguard must not be asked to, or be expected to, watch any one child.
- C. No pets of any kind are permitted in the pool enclosure.

D. Glass containers are not permitted in the pool enclosure.

E. The Clubhouse Manager is in charge of the oversight of the swimming pool and its operation, including the maintenance of good order, cleanliness, and safety on the premises.

F. Members, their children, and their guests are expected to conduct themselves in an orderly manner in or near the pool area. Please comply with the directions and requests of the lifeguard.

G. Grandchildren, eight years old or younger, of members with pool privileges may use the pool twice a month without paying guest fees.

VII. GOLF

A. Sign in before teeing off. If using a cart, amendments made be made to the number of holes played at the end of play.

B. No more than two (2) players are permitted in a golf cart.

C. No-one under the age of 16 is allowed to operate a golf cart.

D. Keep carts away from greens, tees, and traps.

E. Use the 90-degree rule at all times – i.e. keep carts in the rough and cross fairways at 90 degrees only.

F. Metal spikes are prohibited.

G. Fill divots, fix ball marks on greens, and smooth foot tracks in sand traps.

H. Do not throw burning cigarettes or cigars on the grass. Dispose of butts in trash containers, and ensure that butts are completely out before disposal.

I. Let faster groups play through.

J. A member must be present in every foursome, i.e. each member is limited to three guests for any golfing activity.

K. Scheduled golf tournaments and other organized events take priority over individual golf play.

L. The golf course does not have practice facilities. Members may practice between the first and sixth fairways as long as it does not interfere with play or professional lessons. In addition, with the overriding

considerations of speed of play and course condition, a limited amount of practice on the course during a round will be tolerated so long as speed of play is maintained.

M. Decisions as to course conditions that would prohibit play or alter use of carts shall be made by the Superintendent or, in his or her absence, a member of the Golf Committee. It is advisable to call the club on questionable days before coming to play.

N. Any reported infraction of these aforementioned rules shall result in the posting of the name of the violator(s) on the Club premises and/or in the newsletter. The violator(s) shall then be required to explain his/her actions to the Board of Directors. Failure to present oneself to the Board may result in the suspension of that individual's golf privileges for a period of 30 days. A second infraction shall result in the automatic suspension of golf privileges for a period of at least 30 days. Any further violations may result in the institution of a termination proceeding pursuant to the Millwood Country Club Bylaws, Article VII, Club Rules, Section B, Conduct.
